Copper [90 <sup>th</sup> percentile result]	0.182 mg/L	Corrosion of household plumbing; erosion of natural deposits Action Level = 1.3 mg/L
Hardness	4	Natural calcium / magnesium content in the water
Alkalinity	356 mg/L	Ability of water to neutralize acid and bases and maintain a stable pH
Nitrate	0.02 mg/L	Runoff from fertilizer use; leaching from septic tanks, sewage; erosion of natural deposits  MCL = 10 mg/L
Arsenic	ND	MCL = 0.010 mg/L

## **Definitions**

- mg/L milligrams per liter; one milligram per liter is equal to one part per million (ppm), which
  is approximately the same as 1 second in 11.5 days
- ug/L micrograms per liter; one microgram per liter is equal to one part per billion (ppb), which is approximately the same as 1 second in 31.7 years
- N/A not applicable
- ND not detected
- MCL Maximum Contaminant Level the highest level of a contaminant allowed in drinking water under State and Federal regulations
